On behalf of the Con Alma Health Foundation Board of Trustees, Community Advisory Committee, and the Staff we are pleased to present our 2005 Annual Report. During this year we awarded 24 Target Grants, 14 Small Project Grants and 3 Discretionary Grants totaling \$1,178,000. Since inception in 2001 we have awarded over \$3.5 million. The 2005 Target Grant award is the last year of a three-year grant cycle focused in the area of reducing youth risk behaviors. We believe that by working together with nearly 250 not-for-profit organizations across New Mexico we are breaking down barriers to health care access and building healthier communities in which everyone has a voice. Our grantees are the champions working on behalf of the uninsured and underinsured diverse populations of New Mexico.

This year has been one of Foundation growth; increasing our granting investments and bring on Deborah Boldt, MPA as Program Officer. The Con Alma Community Advisory Committee also provided excellent community and grantee outreach with over 30 site visits and four community public forums. These community forums provided an opportunity for citizens to share ideas to enhance existing health care and identify important health issues facing their communities.

Con Alma continues to focus our efforts on collaboration with health professionals, community, government, business leaders, and other foundations. We know that in order to improve the health status of all New Mexicans and to leverage resources, collaboration is critical to our success.

GRANT GUIDELINES

POLICIES: Grant recommendations are made by the Con Alma Health Foundation Grantmaking Committee and are ratified by the Foundation's Board of Trustees.

FUNDING RESTRICTIONS: Grants are limited to qualified 501 (c)(3) nonprofit organizations serving the residents of the state of New Mexico. Grants are not made to individuals, for scholarships, or for bricks, mortar, or property.

AREAS OF INTEREST: Con Alma Health Foundation focuses broadly in the areas of health and human services with special emphasis

on culturally diverse, rural, and tribal communities. Con Alma gives priority consideration to proposals that demonstrate strong collaborative relationships, have multiple funding sources, have a plan for sustainability, and address systemic change rather than direct services.
